



STADIUM REGULATIONS

SÜDTIROL ARENA ALTO ADIGE

1. SCOPE

These stadium regulations govern the use and ensure the safety of the premises of the Südtirol-Arena Antholz including associated access and exit points and car parks.

2. ACCESS CONTROL

Access to events is only possible with a valid ticket or other access authorisation*. Visitors with reduced price tickets must present proof of the reason for the reduction. Tickets and evidence for a price reduction must be presented at the entrance and shown or submitted to the police and security staff on request at all access points. Tickets and other access authorisation must also be presented on request after entry at all times.

Driving and parking inside the grounds is only permitted with a special permit. All restrictions must be complied with. Standard road traffic regulations apply throughout the site. Access for emergency vehicles must be assured at all times.

For reasons of safety access and entrance to the site and to the marquees can be prohibited temporarily.

3. CARRYING PROHIBITED ITEMS

At the entrance to the event area, all visitors are obliged to allow themselves to be checked by the security staff for any prohibited items that may not be taken into the venue by having their clothing scanned or by using a metal detector (or other technical device). On request, the security staff must be allowed to inspect any containers (bags, backpacks etc.) carried into the event area.

It is prohibited to take following items into the venue:

- Objects that are prohibited by law from being carried in public, such as weapons, knives, knuckledusters, batons of any kind, etc.;
- Banners with offensive or political, racist, xenophobic, anti-Semitic or violence-glorifying content;
- emblems or symbols belonging to or common to organisations, associations, movements or groups that propagate ideas based on racial or ethnic superiority or hatred, or that incite racial, ethnic, national or religious discrimination;

- Fireworks and pyrotechnic objects or articles of any kind (including Bengal fires, smoke bombs, firecrackers) as well as objects that could pose a danger due to their flammability, e.g. torches, etc.;
- Addictive substances of any kind as well as tablets and powders in plastic bags or other unusual containers;
- Glass containers, glass bottles, cans, jars and jugs of all sizes;
- Items made of fragile, splintering or particularly hard material;
- Plastic bottles over 1/2 litre;
- Tetra packs over 1 litre;
- Non-flexible flagpoles that pose a danger to others;
- Spray cans and colourings of any kind;
- Megaphones;
- Laser pointers;
- Sledges, bobsleighs, skis and similar equipment;

The police and persons or authorities appointed by the organiser to carry out checks may, for safety reasons and at their own discretion, confiscate any object considered dangerous due to its form, content or structure, even if not explicitly listed above.

If prohibited items, objects or substances are found, the police authorities will be informed immediately.

4. PROHIBITION OF COMMERCIAL ADVERTISING

All advertising for commercial reasons during the event is only allowed with permission by the organizer. It is also not permitted to make or use photos, films or voice recordings for commercial purposes.

Ticket holders agree that the organizer may without remuneration record images of the ticket holder, duplicate them and use them for audio-visual media.

This agreement is not restricted in terms of time and location.

5. RIGHT TO CONTROL ACCESS TO THE PREMISES, BEHAVIOUR ON SITE, REQUEST AND OBLIGATION TO FOLLOW

As organizer, the Biathlon World Cup Committee has the right to control access to the premises of Südtirol Arena during the event. All visitors must conduct themselves on the site so as not to endanger or harm other people or to damage property and so that as far as possible other people are not impeded or inconvenienced.

In the interest of safety and the orderly running of the event all visitors must follow any respective requests by the organizer, the police, fire brigade and the security officers working for the organizer.

6. WHEELCHAIR SPACES

Please note that for safety reasons there is a limited number of wheelchair spaces in the grandstands and along the route at each event. Wheelchair users must reserve these spaces with the booking office in advance. Parking and transport can only be arranged after successful booking.

7. ACCESS PROHIBITION/STADIUM BAN

Police or the organizer or persons authorised by the organizer can refuse persons listed below access to the event site or expel them from venue, without reimbursement of the entrance fee, in order to protect property or to ensure the safety of life and health of others:

- People who are obviously under the influence of alcohol or drugs
- People acting violently or who give rise to suspicion of acting violently
- People who cannot provide evidence for their access authorization
- People who represent a safety risk or who refuse to give permission to be searched
- People who refuse to show their ID when requested and who refuse to be searched for prohibited items
- People who carry items that are illegal to possess or carry
- People who refuse to deposit in an appropriate place, items that could be used on site for the purpose of prohibited actions or that are dangerous
- People who refuse to follow the safety instructions by the police, fire brigade or security officers working for the organizer

8. LIABILITY

The access and use of the facility is at your own risk! The organizer is only liable for any damage caused by the intent or gross negligence by his legal representatives or vicarious agents, unless important contractual duties are also affected. Except for intentional action, the organizer's liability is also restricted to foreseeable damage typical of this type of contract unless gross breach of important contractual obligations applies. Accidents and damage are to be notified immediately.

The organiser accepts no liability for stolen items.

9. VIOLATIONS

People who violate these regulations may be subject to sanctions (expulsion, stadium ban, criminal charge). The right to claim damages through the courts remains unaffected. Any contravention of the regulations and especially any behaviour that threatens safety and security, entitles the security services to ban the offending person from the stadium and the site.

All relevant information on the facts of the matter including personal information collected in the context of disciplinary action against an infringement of the regulations will be made available to the responsible authorities for initiation of criminal prosecution and to determine appropriate measures. The right to legal claims for damages is reserved.

All criminal offences and misdemeanours will be reported to the police.

10. VOICE AND IMAGE RECORDING

Everyone who enters the site accepts that they visit a public event and agree that they may be the subject of non-remunerated voice and image recordings, which may be used without recompense in the form of direct or time-delayed video displays for direct or time-delayed transmission or recording, through photos or other media technology.

Visitors are also aware and agree that for safety reasons and to prosecute infringements of these regulations and of the law, CCTV recordings of the spectator areas may be made throughout the site. All people entering the site irrevocably agree that all current and future media may use their image

and voice free of charge for photos, films (motion pictures), live transmissions, broadcasts and or recordings of images and or sound, which are being made by the organizer or his authorised representative in the context of the visit to the stadium or the event.

Every person who enters the site recognises that they may make voice or image recordings and or descriptions of the site or the event, of results and or statistics of the event only for personal use. Full or partial transmission or supporting another person in the full or partial transmission via the Internet, radio, television or other current and or future media technologies of voice and image material, descriptions, results and or statistics of the event is strictly prohibited.

11. FINAL PROVISIONS

This stadium regulations apply to all events in relation to the IBU World Cup Biathlon Antholz/Anterselva (ITA) as well as to all other events in the Südtirol Arena Alto Adige. The current version of these regulations will be made available to visitors in an appropriate way (publication on the organizer's website, display of excerpts at ticket outlets and around the site).
